#### Purpose:

Stewards Individual Placements, a program of Conservation Legacy, provides individuals with service and career opportunities to strengthen communities and preserve our natural resources. The Community Volunteer Ambassador (CVA) Program combines the strength of a national leader in conservation service with the National Park Service to train emerging leaders to assist park units in building lasting connections to communities.

Bandelier National Monument has an active volunteer program, representing all of the park divisions. The program runs throughout the year and has a strong commitment from the local communities.

Bandelier National Monument is recruiting for a CVA to assist with streamlining the volunteer program. The CVA will help to automate the volunteer program and increase volunteering within the park.

# **Description of Duties:**

- Assist with volunteer recruitment
- Assist with getting BAND VIP documents online, utilizing Volunteer.gov
- Work with park divisions to enhance specific program volunteer opportunities
- Assist with VIP training, onboarding, off boarding, CVA will be part of the Interpretation and Visitor Services Division
- CVA will assist as necessary with division duties
- Assist with participation in outreach and special events
- CVA will be encouraged to join park teams such as Safety, Wilderness, Mastermind Council, Social Media Team, etc.
- Manage volunteer uniform cache

#### **Our Commitment:**

Conservation Legacy is committed to the full consideration of all qualified individuals and will ensure that persons with disabilities are provided reasonable accommodations to perform essential job functions. Physical requirements may include periodic overnight travel, non-traditional work hours, ability to move across varied terrain, use programspecific tools and a range of technology on an infrequent or frequent basis. Exerting up to 25 pounds of force occasionally to lift, carry, push, pull, or otherwise move objects. The ability to safely drive an organizational vehicle may also be required for some positions. ## **Time Requirements:**

- Typically, this position is expected to serve 40 hours per week, but exact service schedules may vary. A half hour lunch break will not be counted towards AmeriCorps service
- Member may be required to participate in national, state, or local service projects or events as part of their service term.

#### Orientation and Training:

- Member will receive an orientation that includes training on AmeriCorps prohibited and unallowable activities.
- Week-long, in-person training on NPS volunteer program management and leadership skills
- Year-long continuum of learning supporting professional development
- \$750.00 in Professional Development Funds for travel and training

## **Additional Position and Community Information:**

Schedule will include weekends and evenings as needed.

NPS Host Site will provide housing at no cost to the CVA. Housing will be remote and a vehicle will be needed to travel outside the park for groceries, medical, gas, etc.

# **Evaluation and Reporting:**

Reporting requirements include, but are not limited to, bi-weekly timesheets and accomplishment tracking.
